The final Offer Price has been determined at HK\$0.56 (exclusive of brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net proceeds from the Share Offer

Based on the final Offer Price, the net proceeds from the Share Offer, after deducting related underwriting fees and other estimated related cost payable by the Company in connection with the Share Offer, are estimated to be HK\$92.9 million. The Company intends to apply such net proceeds in accordance with the purposes set forth in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Of the 27,362 valid applications on **WHITE**, **YELLOW** and **PINK** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 32,793,400,000 Public Offer Shares:

- a total of 24 valid applications have been received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 3,830,000 Employee Reserved Shares, equivalent to approximately 1.92 times of the total number of Employee Reserved Shares available for subscription under the Employee Preferential Offering. As the Employee Preferential Offering has been fully subscribed for, none of the Employee Reserved Shares have been made available for subscription by the public under the Public Offer. The final number of Employee Reserved Shares allocated to the relevant Eligible Employees under the Employee Preferential Offering is 2,000,000 Offer Shares, representing 1% of the total number of the Offer Shares available under the Share Offer.

The Directors also confirm that (i) the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; and (ii) the Shares will be held by at least 300 shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.
